The sixth form at Archbishop Sentamu Academy has provided our students with a high quality of education since its inception. It has prepared students for higher education, employment and training with many of our leavers going on to study at university and has been an important part of the school to date.

Over the last few years, falling numbers in the sixth form have meant that it has become less viable to run. Following consultation with regard to a proposed 'Significant Change' to close the sixth form provision within our school from September 2024 we are launching a consultation in respect of the academy's Admission policy. This consultation period is for a period of 4 weeks (dates stated above).

All responses to this 'Admission Consultation' will also be forwarded to the Trust Board for consideration and outcomes shared with the Department for Education inline with the procedures stated within their <u>Making a Significant Change to an Academy (effective from April 2024)</u>.
